

2nd ADDENDUM TERM TO INTERNATIONAL COOPERATION AGREEMENT



Second addendum term to the general agreement of academic and scientific cooperation between the Federal University of São Carlos (Brazil) and Helmholtz-Zentrum Geesthacht Zentrum für Material- und Küstenforschung GmbH (Germany) executed on September 30, 2014

The Federal University of São Carlos, based on São Carlos campus, at *Rodovia* Washington Luís, km 235, in São Carlos, in the state of São Paulo, Brazil, in this act represented by its rector, Prof. Dr. Wanda Aparecida Machado Hoffmann, Ph.D., hereinafter referred to as "UFSCar"; and *Helmholtz-Zentrum Geesthacht Zentrum für Material- und Küstenforschung GmbH*, based at 1 Max-Planck-Straße, in Geesthacht, in the State of Schleswig-Holstein, Germany, in this act represented, as a statute, by its scientific director, Prof. Dr. Wolfgang Kaysser, and its administrative director, Ms. Silke Simon, hereinafter referred to as "HZG";

WHEREAS both institutions entered into a general agreement of academic and scientific cooperation on September 30, 2014, in order to establish stable relations between them, so as to conciliate together the development of programs, plans, projects and research activities, as well as to establish methodology towards the development of joint activities, particularly in as far as research work, training and staff exchange is concerned;

WHEREAS the same parties executed a 1st additive term to said agreement on September 30, 2014, which main objective is to develop a closer cooperation between them in the fields of research and teaching in the areas of Materials Science and Engineering;

WHEREAS the validity of the general agreement, pursuant to its Sixth Clause, will end on September 30, 2019, and the parties thereof wish to formally extend the academic and scientific cooperation between them, aiming to keep the opportunity for jointly developing academic and scientific activities of mutual interest;

WHEREAS that agreement, in compliance with its Seventh Clause, may be altered upon consent by both parties with the approval of the corresponding addendum term;

ENTER INTO THIS ADDENDUM TERM in conformity with the following clauses:

First Clause – OBJECTIVE

This addendum term extends for five (5) years, from September 30, 2019, the duration of the general agreement of academic and scientific cooperation between UFSCar and HZG executed on September 30, 2014.

Second Clause – CONFIRMATION

The other clauses and conditions of the agreement referred herein remain unchanged.

AND BEING IN JUST AGREED, the parties sign this instrument in four identical copies, two in Portuguese and two in English, to the same effect.
